 real & personal estates respectively to hold the same unto & to the  
 use of them the said Edward Shindon Joan Anne James Eggar  
 William Cheate & Henry Auden & their Executors Administrators &  
 assigns for ever or according to my estate & interest therein respectively  
 upon the trusts nevertheless following (that is to say) upon trust after  
 payment of my just debts funeral testamentary & other expenses  
 aforesaid that they my said Executors & Trustees or the Survivors or  
 Survivor of them or their heirs Executors or Administrators of one Survivor  
 do & shall carry on my said farming business with the assistance  
 of my children that are now at home with me until my  
 youngest child or the Youngest Surviving child arrives to the age of  
 twenty one years & I will & direct that the maintenance & support of my  
 beloved wife Elizabeth & one of my children as are now residing at  
 home with me & also the Education of my daughter Charlotte be  
 paid by my said Executors & Trustees out of the profits of my real &  
 personal estates during that time in one way & manner as they my  
 said Trustees or the Survivors or Survivor of them or the heirs &  
 Executors or Administrators of one Survivor shall think most proper & as  
 my said wife is very infirm I request that they will take every care  
 of her as they may judge most prudent & proper waite & entirely  
 leave to them & I direct that my said daughter Charlotte may be kept  
 at school till she is fifteen years of age & if it is my desire & I also will  
 & direct that my children who are now residing at home with me

 Executors & Trustees may think proper to order for her use & comfort &  
 from & after the death of my wife I direct my said Executors & Trustees  
 to sell the same & divide the money there arising unto & equally  
 between all my children that shall survive or my youngest child or  
 youngest surviving child arriving to the age of twenty one years as
