said Survivors after payment of all my just debts & testamentary expenses  
& the expenses of the aforesaid sales do & shall pay unto said wife  
the sum of five hundred pounds of lawful money of Great Britain to & for  
her own use benefit & immediate support or do & shall apply the  
same for the maintenance & comfort of my said wife as they may think  
proper & also do & shall immediately after said sales out of the moneys  
thence arising place out to interest the sum of One thousand & four hundred  
pounds in their own names or in the names of the Survivors of them  
either on public or good private real security or securities or on bills  
as they may think proper & pay the interest thereof unto my said wife  
for & during her natural life by half yearly payments or otherwise  
apply the same for & towards her maintenance & support as they may  
judge most proper for her comfort & the said sum of five hundred pounds  
& the interest of the said One thousand & four hundred pounds during  
the life of my said wife as aforesaid I give & bequeath to her  
unrevocably & from & immediately after the death of my said wife  
I will & direct that my said Executors Trustees or the Survivors or  
Survivor of them or the said Executors or Admors of said Survivors  
do & shall sell & get in the said sum of One thousand & four hundred  
pounds & pay & divide the same unto & equally between all my  
children namely Richard Ann Mary Elizabeth & Samuel & every of them  
share & share alike to w&am I give & bequeath the same accordingly  
to & for their own use & benefit respectively & as to all the rest &  
residue & remainder of the money arising by sale of my said real  
& personal Estates as aforesaid after payment of my debts the aforesaid  
expenses & the legacy of five hundred pounds to my wife & after placing  
out the said sum of One thousand & four hundred pounds for the benefit  
of my said wife as aforesaid I will & direct that my said  
Executors Trustees or the Survivors or Survivor of them or the said  
Executors or Admors of said Survivors do & shall pay & divide the  
residue & remainder unto & equally between all my said children  
share & share alike to w&am I give & bequeath the same accordingly to  
& for their own use & benefit respectively & I do hereby will & direct  
that each of said children shares of my said Estate & Effects shall be  
considered as vested interests in them respectively from the day of my  
death & I declare that the receipt & receipts of my said Executors  
Trustees or the Survivors or Survivor of them or the said Executors or  
Admors of said Survivors shall from time to time be a good & sufficient  
discharge or good sufficient discharges to the purchaser or purchasers of all or  
any part of my said real or personal Estates respectively for so much money  
or in such receipt or receipts shall be expressed to be received by them  
& that the purchaser or purchasers shall not concern himself or  
themselves with or be obliged to see to or at all answerable for the  
application misapplication or nonapplication of the purchase money or  
any part thereof provided always in case my said Executors Trustees  
or the Survivors or Survivor of them or the said Executors or Admors  
of said Survivors should think it advisable & most to the advantage of my  
said family to discontinue & cease to carry on my said farming business  
previous to my youngest child attaining the age of twenty one years  
then I will & direct that it shall be lawful for them so to do & in that  
case it is my will & desire & I do hereby direct that they shall do  
sell & dispose of my said real & personal Estates respectively & pay plans  
out & divide the moneys thence arising in such & like manner in  
every respect as they are accordingly directed to sell & dispose of the
