THIS IS THE LAST WILL AND TESTAMENT

I hereby revoke all former Wills Codicils and Testamentary Instruments made by me and declare this to be my last Will.

I appoint my friends Albert Hunt of 57 Dads Lane Kings Heath Birmingham aforesaid Solicitor's Clerk and Annie Rawstrone of 56 Preston Road Freckleton near Kirkham in the County of Lancaster Spinster (hereinafter called "my Trustees") to be the Executors and Trustees of this my Will And I declare that the expression 'my Trustees' hereinafter used shall include the said Albert Hunt and Annie Rawstrone and the survivor of them or other the Trustees or Trustee for the time being of this my Will.

I give and bequeath the following pecuniary and specific legacies and bequests namely To the said Albert Hunt if he shall prove my Will and act in the trusts thereof the sum of Ten Pounds To my Cousin Mary Mantell the sum of One Hundred Pounds To my Uncle Frederick William Wilson the sum of One Hundred Pounds and my Violin To my Aunt the Wife of the said Frederick William Wilson the sum of One Hundred Pounds To my Cousin Lizzie Mantell the sum of One Hundred Pounds To my friend Bert Smith of San Francisco the sum of Fifty Pounds To my friend W Munro the sum of Fifteen Pounds To my Housekeeper Louisa Smith whether in my service at the date of my decease or not the sum of One Hundred Pounds To my friend and Solicitor Herbert Williams the sum of Ten Pounds To the Preston Camera Club the sum of Twenty Pounds in memory of my late Father Charles Mantell and also the Microscope together with Slides and parts which belonged to my late Father And I declare that the receipt of the Secretary or Treasurer for the time being of the said Club shall be a good and sufficient discharge to my Trustees for the said legacy and bequest To the Unitarian Chapel Church Street Preston the sum of Thirty Pounds also in memory of my late Father and also my set of volumes "Poetical Works" (Peoples Standard Library) and it is my desire and wish that the Trustees of the said Chapel shall erect and place a suitable memorial Tablet in memory of my late Father in a suitable position inside the said Chapel And I declare that the receipt of the Treasurer or other duly authorised Officer of the said Chapel shall be a good and sufficient discharge to my Trustees for the said Legacy and bequest and that they shall not be in any way whatever concerned to see to the application thereof To Lizzie Mills the sum of Ten Pounds To Edith Gardner the sum of Five

I give devise and bequoth all the rest residue and remainder of my real and personal estate whatsoever and wheresoever of or to which I may be seised possessed or entitled at my decease Unto my Trustees Upon Trust to sell call in and convert the same into money or such part thereof as shall not consist of money and with and out of the proceeds of such sale calling in and conversion and my ready money to pay my funeral and testamentary expenses and debts and the pecuniary legacies given by this my Will or any Codicil hereto and the legacy duty payable thereon and on the specific bequests given by this my Will or any Codicil hereto and to stand possessed of the net moneys arising from such sale calling in and conversion as aforesaid subject to and after payment thereof as hereinbefore directed and the investments representing the same and the rents and income thereof respectively Upon Trust for the said Annie Rawstrone absolutely and beneficially in the hope and with the confidence that she will dispose of the same according to my known wishes as far as practicable but without creating any trust or legal obligation in respect thereof whatsoever.
5. I declare that my Trustees may in their absolute discretion postpone the sale calling in or conversion of the whole or any part or parts of my residuary estate including property of a terminable hazardous or wasting nature during such period as they shall think proper and to retain any investments existing at my death without being responsible for loss.
6. I declare that my Trustees may in their absolute discretion appropriate or allocate any part or parts of my real or personal estate to any Legatee or Beneficiary under this my Will or any Codicil hereto at Probate or other Valuation figures instead of selling the same.
7. I declare that all legacies and bequests given or made by this my Will or any Codicil hereto shall be paid or given free of Legacy Duty which shall be paid out of my residuary estate as hereinbefore directed.
8. I declare that it is my desire that my Trustees shall employ my Solicitors Messrs. E. R. Williams & Son of Birmingham to act for them in connection with the proving of this my Will and the administration and winding up of my Estate.
