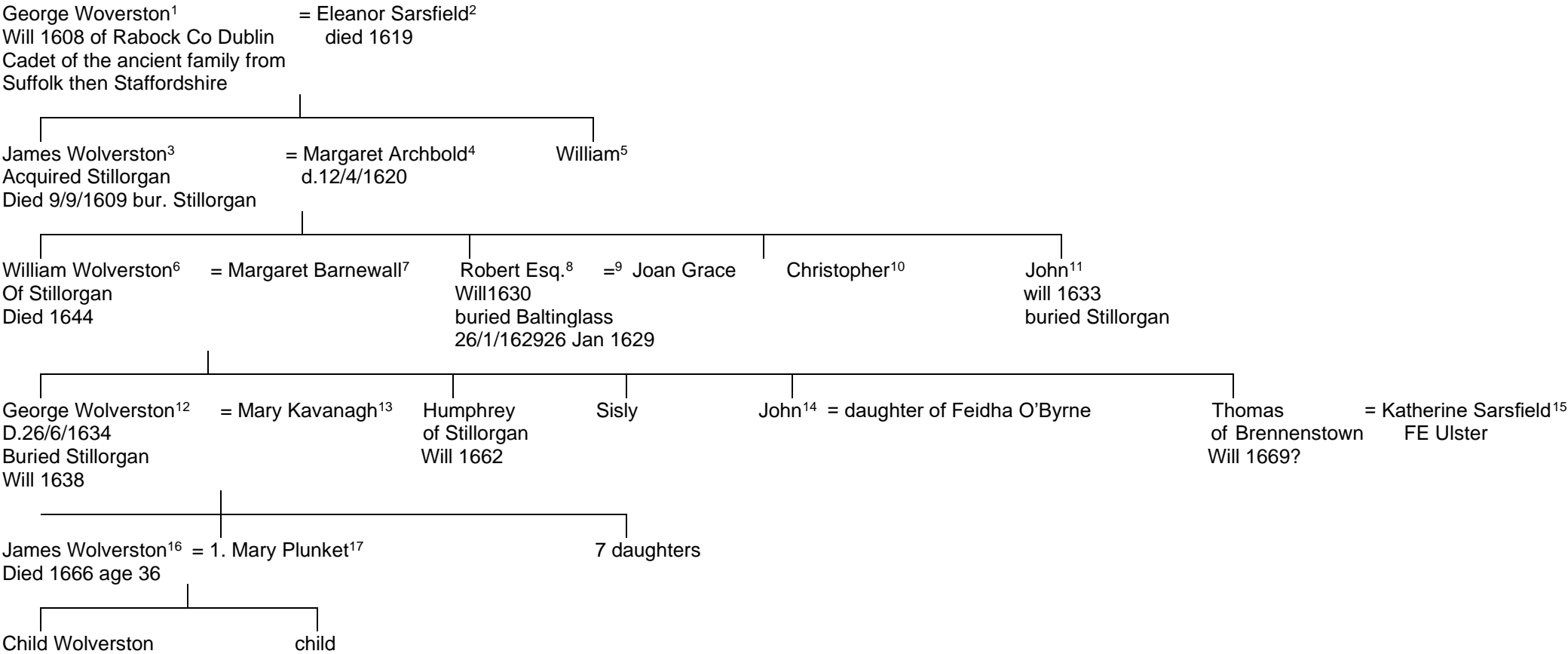

In 1564 the Wolverstons of Stillorgan owned a good slated house. The Wolverstons of Stillorgan can be found Reportorium Novum 2 (2), 1960 Wolverston or Woolverstons of Stillorgand held 500 and more acres of land in the 17th century dublin They were originally of a Suffolk family. In Irleand they were Catholic. They also owned lands of Hacketstown .

Mr Wolverston married Elizabeth Loftus as her first husband no issue she remarried after his death Capt James Sinock and had issue. James Wolverston of Stillorgan Co Dublin son of George Wolfverston a native of Suffolk, he had been English Captain of Crioch Bhranach. He also owned property Co wicklow. He died 1609 leaving his diow a daughte of Richard Archbold of Kilmacud and four sons of whom John the youngest succeeded to lands near Newcastle Co Wicklow married in 1625 a daughter of Feidhlin O Broin eldest son of Fiache Mac Aodha (I think it had to be his grandson John not his son, the dates do not make sense otherwise) see Ball's Co Dublin 1 118, O Don A.F.M paged 2018 JRSI vol 45 page 112. In one account it sayus Mames mother was a Rochort of Kilbogget but I think this was a much later James and it was that James uncle who was married to the widow of Rochfort alias Sarsfield. This James saw military service but after he acquired Stillorgand devoted himself to the improvement of his estate. Lieutenant Wolverston whose horse was slain under him in action in 1592 was recommended for favourable consideration after 17years served. When James died he possessed much land in Co Dublin and Wickow , he had herds of Garrens, of coes and of swine, of flocks of sheep, of a stud of horses at Glencullen, and of another at Frainestown, besides great stores of corn, much household stuff and plate. He mentions in his will, besides the farm and towns of Stillorgan, the lands of Newtown and of Glencullen Co Dublin and the lands of Ray, Kilpoole, Monckland and Frainestown co Wicklow.
